

SUPPORTING MARK SEXTON – HOW TO PREPARE YOUR COMPLAINT

As the rumours increase that 'optional' is to be changed to 'compulsory' on taking the bogus jabs, this attachment here is now extremely relevant and timely.

There is a link below to show exactly how this former police constable **Mark Sexton**, bravely went about lodging HIS personal CRIME REPORT at Leamington Spa Police Station.

Before handing the four-page document over to any officer:

1. WE have to fill out Page 4 - Section a), together with OUR name and our address at the foot of the page.

2. Get two persons to sign and date the bottom of Page 4 beforehand, and have these two witnesses with you when you hand it over..

3. We also need to complete Page 4 - Section c) with the officer's details, getting the 'Rank' (PC / Sergeant/ Inspector, etc) plus their NAME if they will give it, and the SHOULDER number if it is a PC / Sergeant - (above these two ranks those numerals disappear).

(You should be aware that, in addition to any numbers/letters on their epaulettes, EVERY police officer carries a Warrant Card, issued to them on entry to the service.

This card involves a different ID number. These are often EIGHT or NINE digits, very much like the service ID numbers issued to military personnel - eg:38/154567..)

Our advice is that the prepared document should be handed to an INDIVIDUAL police officer (*and, please remember, however far up the promotion ladder these men and women progress, they never STOP being a 'constable', even if they become 'superintendents' or higher*) preferably in the street, since any document simply handed in at a police station front desk could end up in the rubbish bin, if we did not get the name and Identifying 'shoulder' number of the person to whom we gave it.

We may have to pester them at our local police station for the **Crime Report Number**, as it is unlikely that any officer in the street will be able to give that information straight away, although they should send it in writing to the address you give at the bottom of Page 4..

REPORTING THE UNLAWFUL "UK Coronavirus Act 2020"
