## DIMINISHED CAPACITY OF STATUS AND LEGAL CAPACITY

What you are reading here, although devised many centuries ago, is not merely historical - the present Crown agents are still applying exactly the same principles to us, the **proletariat** (*ie: those without substantial capital, who are dependent upon selling their labour to exist*), today.

In Roman law, a 'diminishing' (*meaning: to make or become less*) or 'abridgment' (*meaning: the curtailment of rights*) of personality was and still is used as a loss or curtailment of status or aggregate of legal attributes following certain changes in a '**person**'s' civil condition.

There are three kinds of status and standing which are as follows:

(a) **CAPITIS DIMINUTIO MAXIMA** (*the use of all capital letters in a name*)

The highest or most comprehensive loss of status:

This occurred when a man or woman's condition was changed from one of **freedom** to one of **bondage** (*meaning: the state of being a slave*), when a man or woman became a slave through Conversion.

CAPITIS DIMINUTIO MAXIMA swept away with it all rights of citizenship and all family rights.

This was and is achieved by criminal Conversion of a man or woman's name, for example, from **john doe** (*in all lower-case letters*) to **JOHN DOE** or **J DOE** (in all capital letters) without lawful excuse or a lawful right to do so.

(b) **Capitis Diminutio Media** (*the use of capital letters at the beginning of each name*) A lesser or medium loss of status. would be This occurred where a man or woman lost their rights of citizenship, but without losing his liberty. It also carried away the family rights.

## DIMINISHED CAPACITY OF STATUS AND LEGAL CAPACITY

For example, if a man was called **John Doe** (*capital letters at the beginning of each name*) this would be known as Capitis Diminutio Media. We are attaching a present-day 'Court' issued document to prove to you that exactly the same ruling is still being applied to us.

(c) **capitis diminutio minima** (*No use of capital letters in a name*)

The lowest or least comprehensive degree of loss of status

This occurred where a man or woman's family relations alone were changed. It happened upon the arrogation of a person who had been his own master, (*sui juris*) or upon the emancipation of one who had been under the **patria potestas**.

For example, if a man was called **john doe** (*all lower case letters in his name*) this would be known as capitis diminutio minima. It left the rights of liberty and citizenship unaltered.

Under this status, there is no master and no one to answer to for the man or woman's actions.

This means that **anyone under capitis diminutio minima is free to go where he or she wants**.

A 'person' (*we prefer to avoid this Latin-based word - better a living being*), who has reclaimed their name under capitis diminutio minima, cannot be deprived of their liberty, nor be summoned, exorbitantly fined, or be prosecuted in any way.

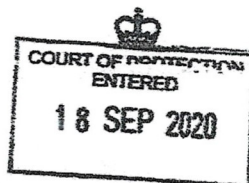

### ORDER APPOINTING A DEPUTY FOR PROPERTY AND AFFAIRS

made by Ross Hamilton, an authorised officer of the court

on 4<sup>th</sup> September 2020

Here she is identified as being the same 'person' when  
her name appears in Capitis Diminutio Media

UPON the court being satisfied that Angela Smith lacks capacity to make various decisions for herself in relation to a matter or matters concerning her property and affairs, and that the purpose for which this order is needed cannot be as effectively achieved in a way that is less restrictive of her rights and freedom of action.

AND UPON the court being satisfied that Angela Smith's interests and position can be properly secured without being joined to these proceedings and without making any further direction concerning Angela Smith's participation in these proceedings.

#### IT IS ORDERED that:

##### 1. Appointment of deputy

...and here, the same LEGAL FRAUD would have us believe that  
her husband is also a 'person', which would make him both GRANT  
SMITH and Grant Smith, a slave in that system

(a) Grant Smith of [REDACTED] is appointed as deputy ("the deputy") to make decisions on behalf of Angela Smith that she is unable to make for herself in relation to her property and affairs, subject to any conditions or restrictions set out in this order.

(b) The appointment will last until further order.

(c) The deputy must apply the principles set out in section 1 of the Mental Capacity Act 2005 ("the Act") and have regard to the guidance in the Code of Practice to the Act.

##### 2. Authority of deputy

(a) The court confers general authority on the deputy to take possession or control of the property and affairs of Angela Smith and to exercise the same powers of management and investment, as she has as beneficial owner, subject to the terms and conditions set out in this order.

(b) The deputy cannot purchase any freehold or leasehold property on Angela Smith's behalf without obtaining further authority from the court.

(c) The deputy must not sell, charge or otherwise dispose any freehold or leasehold property in which Angela Smith has a beneficial interest without obtaining further authority from the court.

So, we see now, how important it is to choose a free/wo/man name, one which cannot  
in any way be construed as being subject to LEGAL FRAUD status.
