THE PROBLEM

We are now, ALL of us, being handled as 'paper dolls' - fictional creations. ILLEGAL CONVERSIONS, PERSONAM, QUASIM and suitable only to be traded as cattle.

THE REASON(S)

Effective since January 1973 [FCO 30/1048] our country has been quietly controlled by a FOREIGN STATE, having been ASSISTED rather than RESISTED by our then monarch. Ostensibly under European, in reality by a yet more obscure power, THE CROWN CORPORATION" appears to own, anywhere ACROSS THE WORLD, anyone who has a birth certificate. This was a sleight of hand called "illegal conversion" and is only a snapshot of the complete horror story. However, this foreign state constrains everyone who has been issued with a birth certificate (*which is in itself an illegal conversion*) settled on us at our birth, to be



regarded as lost at sea, or presumed dead. Our children are targeted from birth as fair game. Every mother, every father, is unwittingly dragged in to play a role in this theatre of DISGUST, their child being allocated both National Insurance and National Health Service numbers from birth.

Folks, the British judicial system is in tatters. Anyone who needs confirmation of that should follow the brave work of one **Martin Geddes***, who is single-handedly challenging every aspect of what the legal eagles have, since 2015, called 'Single Justice Procedure' (SJP). This includes the concept of quietly melding 'criminal' and 'civil' court activity into such a fudge that the 'man-in-the-street' will hardly spot the malfeasance. All courts,
